GENERAL RULES

Entrance to the soccer centres is via the main exterior doors adjacent to the 7v7 centre. There is one-way access from the entrance to the dressing rooms and from the dressing rooms to the soccer fields and one-way egress from the soccer fields to outdoors. Each field has its own entrance/exit. (see diagram.)

All users of our facilities (including, but not limited to, the outdoor fields, the indoor soccer centres and the club house) must create an account on our website <https://www.1stdfcvictoria.com/>. Once you are registered, the "Facility User Registration" button will come up. Click on the button and complete the Facility User Registration (Informed Consent and Assumption of Risk Agreement). This will only need to be done once; prior to your first visit and will be valid for the entire Indoor Season.

All users will be required to login to our website (<https://www.1stdfcvictoria.com/>) and complete the Check-In (Health Questionnaire) a maximum of 24 hours prior to game/practice time and a minimum 1 hour prior to game/practice time.

All adult leagues/casual users/team practices are responsible for completing their own contact tracing logs prior to every game. Contact tracing logs are to be deposited into a secure mailbox labelled as such, on-site due to the sensitive nature of the information. Only Victoria staff will be retrieving the documents and they will be securely kept for 30 days and then destroyed.

EIYSA contact tracing sheets will be maintained by the admissions desk and turned into our office daily. They will also be kept securely for 30 days and then destroyed.

Anyone who has not completed their Check-In on-line, will **not** be allowed into the facility.

No spectators are allowed in the soccer centres; parents are to drop off and pick up their kids at the outside doors for games and practices. See EIYSA specific rules for more information.

As per City of Edmonton By-Law #19408, **face masks are mandatory inside our facilities for everyone, no exceptions.** Face masks are available for purchase for those who have none. <https://www.edmonton.ca/documents/Bylaws/BL19408.pdf>

There is a facility limit for each soccer centre as follows:

- 48 persons maximum capacity for the 7v7 centre and
- 72 persons maximum capacity for the 9v9 centre.

Please do not come earlier than 10-15 minutes before your game or practice time, register, and proceed to the dressing room assigned to your team.

Please leave the field promptly at the end of your game or practice to allow for sanitizing prior to the next game or practice.

Dressing rooms are only "holding" areas pending the start of the game. **Players are to come dressed to play and have a bag for their equipment and outer clothing/shoes.** The bags must be taken onto the fields and stowed under the players' benches during the game. Players may not go back to the dressing room after they have been on the field.

No loitering in the hallways.

Showers are not available.

Referees have their own (secure) dressing room.

No video recording allowed, except for that being done by Victoria Soccer Club. If you wish recording to be done, please contact the Administration Office.

As per ASA and AHS Guidelines and City of Edmonton By-Law, masks are mandatory, except when playing on the playing field. Players may remove their masks and stow them in their bag, prior to going mid-field when substituting.

Physical distancing (two (2) metres) must always be maintained throughout the building, except when playing on the playing field. We have sufficient room on the players' benches to allow this.

The Victoria Soccer Club is participating in the [Restrictions Exemption Program \(REP\)](#).

All ASA policies regarding "[Return to Restriction Requirements & Best Practices Guidelines](#)" are always to be followed.

If ASA policies, AHS guidelines, or City of Edmonton By-Laws change, the latest version will apply.

We will always have our air circulation and purifying system on maximum.

All persons entering our facilities must follow all posted signs and notifications.

As an organization we do not tolerate bullying or attempted intimidation of our employees at any time.

Failure to follow these rules will result in ejection from the facility and a possible ban on attendance at future games or practices.
